## WSFM Health & Wellness Webpage



#### Forest Stewardship and Landowner Assistance Committee

The CWSF Forest Stewardship and Landowner Assistance Committee will meet June 4-6 in Folsom, CA. This will be the committee's first in-person meeting since its formation last year. Attendees will share successes and challenges from their states. The host state of California has a field trip planned that will examine recent fires and the reforestation and restoration taking place in and around those fires.





### Policy Updates

Kelly Norris, along with representatives from the water utilities, the timber industry, USDA, and the U.S. Department of Interior (DOI), testified at the Senate Energy and Natural Resources Committee Hearing to "Examine the Findings and Recommendations of the Wildland Fire Mitigation and Management Commission." Kelly highlighted the importance of cross-boundary management, strong partnerships, and the successful use of GNA in Wyoming. Kelly noted that "states are contributing to the restoration of federal forests at an unprecedented scale." Wyoming State Forestry Division has partnered with the Forest Service and DOI Bureau of Land Management to treat over 11,000 acres and sell approximately 32 million board feet of timber under GNA.

Jamie Barnes, along with four other state and federal officials, testified at the Homeland Security and Government Affairs Committee hearing titled "A Nation on Fire: Responding to the Increasing Wildfire Threat." Jamie highlighted the importance of bringing partners and stakeholders together in a Shared Stewardship approach to do the "right work, in the right place and at the right scale." The Utah Shared Stewardship program has treated over 80,000 acres utilizing this approach.

In preparation for the Senate Interior, Environment and Related Agencies Appropriations Subcommittee hearing on the FY 2025 Forest Service Budget Proposal, CWSF and NASF staff worked with Nebraska State Forester John Erixson to provide information to Senator Fischer (R-NE) on State Forester Priorities.



### A Look Ahead

CWSF/WFLC staff will be working with the WUCF Committee to develop a publication centered around projects and programs made possible with BIL & IRA funding.

CWSF/WFLC staff will also be working with the GNA Committee on an update to the GNA Activities & Accomplishments report.
